**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TROY, MONTANA  
REQUIRING LOG BOOKS BE MAINTAINED BY THE TROY POLICE DEPARTMENT**

WHEREAS, the Troy City Council wishes to establish accountability, transparency and integrity in all the City Departments, including the Police Department; and

WHEREAS, the Troy City Council understands that the Montana Criminal Justice Information Act of 1979 (Title 44, Chapter 5) requires certain information to remain confidential and the Troy City Council does not wish to violate that right to privacy; and

WHEREAS, the Troy City Council wishes that log books be maintained by all police officers.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Troy, Montana that the Chief and Officers of the Troy Police Department maintain log books and submit a copy of such log books to the Council on a monthly basis with any private, confidential or sensitive investigatory information contained therein redacted.
